CLASS TERMS AND CONDITIONS

1. All Funky Moves public classes are following a Covid safety plan to keep attendees, teachers and parents safe at all times. Our teachers have been trained by our Management Team in implementing the safety plan prior to hosting classes.
2. All Funky Moves classes have an updated Risk Assessment integrating Covid related risks – please email us at info@funkymoves.com if you wish to see this.
3. Funky Moves classes are suitable for boys and girls aged 4+ years. Please refer to the age ranges for specific classes, which can be found on our website. Each class is tailored to the specific age group for content and choreography. In certain cases, a child may be allowed to attend a class outside of their age group (this has to be discussed and approved by management) and Funky Moves cannot be held responsible for any choreography or content deemed not age-appropriate.
4. Any pictures/videos taken during a class may be used for promotional and advertising purposes for Funky Moves only. If you would prefer for you/your child not to feature in these, please let us know.
5. Trial classes are offered, subject to availability. Payment for trial classes is non-refundable.
6. All teachers are Fully Enhanced DBS checked and follow our Safeguarding Policy (which can be found on the website).
7. Funky Moves has Public Liability Insurance.
8. Due to unforeseen circumstances or illness, our teacher(s) may change on the day, from the one(s) running the classes for the term.
9. As our costs are fixed if a child cannot attend a class for any reason the class is not refundable, this includes having to isolate for Covid exposure reasons.
10. If Funky Moves has to cancel a class we will refund the proportionate cost of that class/reschedule a replacement class as soon as possible.
11. Cancellation during the term: Payments will not be refunded if you choose to cancel your child/children attending the rest of the term. Exceptional circumstances will be dealt with on a case by case basis.

12. All classes are payable per term, in advance, when your booking is submitted.
13. If classes are cancelled due to Covid related restrictions, the remaining classes of the half term/term will be completed online via the Zoom app. Refunds will not be permitted.
14. If a child starts part way through the term, payment will be due for the remaining classes of the term/half term.
15. Payment for classes will be due ahead of the first week of term. If payment is not settled before the first week of term (without prior discussion), Funky Moves will add a late payment charge to your invoice. If the invoice remains unsettled for a further class, Funky Moves teachers reserve the right to refuse entry of your child to class. These rules apply accordingly to the week following a Free Trial, and the consecutive week after that.
16. Children should arrive promptly, correctly dressed and attend classes regularly.
17. If your child is more than 20 minutes late to class, they will not be permitted to attend (unless previously approved). Lateness greatly disrupts the flow, energy and concentration of the class.
18. Please ensure your child has appropriate footwear – trainers are best. No boots, heeled shoes, Uggs or wellies permitted.
19. Please ensure your child is dressed comfortably for the classes. Girls may find it more comfortable to wear trousers, shorts or leggings rather than dresses or skirts, as a lot of our classes include floor work in the routines.
20. For children's safety, it is the parent's responsibility to bring their child/children into the class. Teachers will dismiss children according to the venue. Please do make a teacher aware of any changes to the person collecting.
21. Please inform your teacher of any injuries before class.
22. Please always provide a drink for your child during the class (water is preferable).
23. Please do not provide your child with a snack – this is for the safety of other children (allergies) and also the danger of undigested food when dancing.
24. Physical contact maybe necessary when helping to demonstrate or correct moves.
25. During class, children are expected to listen and we discourage unnecessary talking. If a child is causing disruption, this will be discussed with the parents and they may be asked to leave the course. Please refer to our Safeguarding Policy for any further behavioral policies.
26. Parents are not permitted to stay and watch the class as we feel the children's focus is greatly affected. However, it is at the teacher's discretion if you would like to stay for part of the child's first class.
27. Funky Moves does not accept the responsibility for items lost or stolen although anything we do find will be returned to the parent.

28. We would appreciate the children being collected promptly. If a parent is over 15 minutes late there may be a monetary late fee due directly to the teacher.

29. Our terms and conditions are supported by our Safeguarding Policy – please read this prior to booking your child’s place.
